Housing Needed in Downtown Albuquerque

An interesting study was summarized in the Albuquerque Journal's Business Outlook on April 30, 2001. According to Richard Metcalf, Associate Business Editor of the Journal, 25,533 people live downtown (data from the 2000 Census), representing 4 percent of the city's total population. The population density downtown is 3,175 people/ square mile, compared to a density of only 114.8 people citywide.

According to Todd Clarke, CCIM, downtown Albuquerque is undersupplied in housing units, based on the ratio between the number of jobs to the number of households in the area. The report indicated that there are 41,574 jobs downtown, and only 10,496 households, a ratio of 25 households/100 jobs, compared with 76 households/100 jobs citywide (based on 259,612 households and 339,927 jobs throughout the city).

The study suggests that the demand for new apartments and homes would be met by building at least 3,000 new housing units over the next 5 years.

As a result of the study, Fannie Mae and First State Bank have already teamed up and are offering \$10 million in financing for the construction of housing projects downtown.
